No.: GHR/2017/51/GSE/19/2016/324393/M:3: In exercise of the powers conferred by the proviso to sub-section(1) of section 4 of the Gujarat Shops and Establishments Act, 1948, (Bom.LXXIX of 1948) (hereinafter referred to as "the said Act"), the Government of Gujarat hereby amends the Schedule II of the said Act, for the purpose of giving exemption to All Shops registered under the Gujarat Shops and Establishments Act, 1948, from the provisions under section 10, 11, 18 and 33 for the period of two years from the date of issue of this notification as follows, namely:-

(12) In case of violation of any of the above terms and conditions noticed by shop inspector, the exemption shall be cancelled after giving notice the shop/ to establishment. In case of violation of any (13)provision of the Gujarat Shops and Establishment, Act-1948, exemption shall be cancelled after giving notice to the shop/establishment.
