Subject: Prohibition of installation of Boilers in residential buildings, Hotels/restaurants, hospitals, malls etc.-regarding

Dear Sir,

As you may be aware that the Central Boilers Board, constituted under the Boilers Act, 1923 comprises of the representatives of the Central and State Governments, Bureau of Indian Standards, Boiler and boiler component Manufacturers, National Laboratories, Engineering Consultancy agencies, users of Boilers and other interests connected with the Boiler Industry. Secretary, Department of Industrial Policy and Promotion is the ex-officio Chairman and Technical Adviser (Boilers) is the ex-officio Member-Secretary of the Board.

2. Board deals with the problems of both the users and manufacturers and takes policy decisions for proper growth of the boiler manufacturing industry in the country. Board also formulates the Indian Boiler Regulations incorporating the latest developments taking place in the Boiler Industry all over the world.


3. For the safety of life & property from the danger of explosion of boilers, it is proposed that boilers should be installed in a separate building and these should not be allowed to be installed in buildings where large number of persons are present like residential buildings, hotels, restaurants, hospitals, malls etc. However, boilers may be allowed on roof top of buildings provided structure of building is fit for such installation. This is proposed to be made applicable to existing boiler installations also for which owners may be given two years' time for relocation of boilers.

4. Before making rules/regulations for implementing the proposal, the stakeholders like CBB members/CII/FICCI/ASSOCHEM/FIEO/ Associations for Hotels/Malls/ Hospitals etc. are requested to give their comments/suggestions on the

proposal as per para 3 above. The stakeholders are requested to offer their comments/suggestions within a period of two months from the date of issue of this letter.
